



## Manufacturer's Extended Limited Warranty for Idle Free APU System

### Extended Warranty Coverage

Idle Free Systems, Inc. ("Manufacturer") warrants each Idle Free APU System ("System") against defects in material and workmanship under normal use and service conditions. This Extended Warranty starts the month following the end of the original Manufacturer Warranty.

Within the extended limited warranty coverage period, all warranty repairs and services must be pre-approved and performed by an authorized Idle Free Systems, Inc. dealer.

Repair or replacement under the terms of this extended limited warranty does not provide a right to extension or renewal of the extended limited warranty coverage period.

This extended limited warranty extends to the original purchaser and subsequent owner for the first installation during the extended limited warranty coverage period.

Only the following parts/components are covered within this extended warranty: (i) Evaporator Fan; (ii) Condenser Fan; (iii) Compressor; (iv) Coolant Heater (does not include heater burner basket); (v) Inverter (does not cover the internal fuse); (vi) DC Power Converter/Battery Charger (shore power) (does not cover fuses); (vii) Battery Separator; (viii) Start Capacitor; and (ix) Thermostat.

### Extended Warranty Exclusions

This extended limited warranty does not cover routine maintenance, and also does not cover System issues:

- a.) caused by unreasonable or unintended use of the System;
- b.) which occur after the expiration of the limited warranty coverage period defined above;
- c.) caused by improper installation;
- d.) caused by the System being maintained, altered, modified, opened or repaired, other than by an Idle Free Systems, Inc. authorized dealer/technician;
- e.) caused by misuse, abuse, accidents, neglect, absence of scheduled maintenance, acts of God, vandalism, flood, fire or any other occurrences beyond the control of Manufacturer;
- f.) related to inverter failures caused by driver plug-ins
- g.) related to any components or parts not supplied by Manufacturer which are attached to any part of the System or any damage done to the

System as a result of parts not supplied by Manufacturer being attached to any part of the System; or

- h.) related to repair or replacement of batteries, which is governed by a separate warranty agreement.

### How to Obtain Extended Warranty Service

To qualify for the extended limited warranty, buyer must have registered the product with Manufacturer within thirty days of purchase.

To obtain extended warranty service, the buyer must notify an authorized Idle Free Systems, Inc. dealer of any defect, malfunction, or nonconformity promptly upon discovery.
